### DIRECTIONS FOR USE

Mixing: SOLV-KLEEN requires no premixing. The product is ready for use directly from the container.

Cleaning Sprayers: Run SOLV-KLEEN through equipment until coating residue is completely flushed out. Capture runoff and excess in an approved container and dispose of in accordance with local regulations.

Sealer Stripping: Apply SOLV KLEEN directly to the area to be stripped. Keep the area wet and allow to soften for 5 to 10 minutes. Reapply additional solvent and begin resin removal by scraping or scrubbing. Additional applications may be necessary to remove all the sealer.

### PRECAUTIONS/LIMITATIONS

- Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking.
- Close ventilation air intakes if they will distribute solvent odor into adjoining occupied sections of buildings.
- Wear appropriate hand/skin/eye/face/respiratory protections.
